4.2 Bank of China (Canada)

Bank of China (Canada)
- BOCC

Bank of China (Canada) BOCC is the first Chinese Bank to enter the Canadian Market.

BOCC was incorporated as a Schedule II bank in 1992. It provides full-services and carries on business under Canada's Bank Act and operates under the supervision of the Office of Superintendent of Financial Institutions (OSFI). BOCC is a member of the Canadian Bankers Association, Canadian Payments Association, as well as the Canada Deposit Insurance Corporation ("CDIC").

BOCC is in a unique position to provide services bridging the trade and investment activities between Canada and China. Our mission is to facilitate the economic and trade development of Canada and China.





4.3 Bank of China (Canada) Branch Network

■BOCC opened its first branch in Toronto's Chinatown in 1994, followed by the Vancouver branch in 1995. Branches in Scarborough, Markham and North York were opened in 2005, 2008 and 2010 respectively. With the establishment of the branches in Calgary, Richmond, Mississauga, Burnaby and Montreal from 2011 to 2013, the number of branches has reached TEN plus a VIP center in Markham.
